

## NWAC EXECUTIVE DIRECTOR JOINS NATIONAL INDIGENOUS FINANCIAL LITERACY WORKING GROUP

OTTAWA, ON – A new working group has been established within the Financial Consumer Agency of Canada that will assist in responding to the financial literacy needs of Indigenous Peoples, including Métis, First Nations and Inuit. Native Women's Association of Canada (NWAC) Executive Director Lynne Groulx has joined this newly formed national working group.

The Group's objectives are to address the unique barriers faced by Indigenous Peoples in achieving financial well being. They will begin with addressing the obstacles in design, delivery and measurement of financial literacy interventions. The wealth of knowledge, diversity, gender perspective and experience in the collective group will immediately begin collaborating to share information, identify priorities and develop new programs and initiatives; additionally, a focus on community driven financial priorities will be created for and with Indigenous priorities.
